**SUPPLEMENT AGREEMENT NO. 1 – Amendment 1  
TO AGREEMENT NO. 100504 – SAI – 001  
BETWEEN THE CITY OF PHOENIX  
AND  
THE DAISY MOUNTAIN FIRE DISTRICT  
FOR SHARING OF COMMUNICATIONS FACILITIES**

Pursuant to Intergovernmental Telecommunications Facilities Sharing Agreement No. 100504 (“Agreement”) entered into as of the 1<sup>st</sup> day of March, 2002, (the “Effective Date”), the CITY OF PHOENIX and the DAISY MOUNTAIN FIRE DISTRICT now desire to enter into this Amendment 1 to the site-specific agreement Supplement No. 1 (“Supplement”) to the Sharing Agreement.

In Section 2.5. Equipment Installation, of Supplement No. 1 to Sharing Agreement No. 100504, the following Section 2.5.3 has been added:

**2.5 EQUIPMENT INSTALLATION:**

2.5.3 DAISY MOUNTAIN FIRE DISTRICT shall install a Point-to-Point (PTP) microwave radio and antenna on the Regional Wireless Cooperative (RWC) tower to support data network needs. DAISY MOUNTAIN FIRE DISTRICT agrees to provide PHOENIX two T1’s on this microwave link to the Phoenix Outlet Mall site.

All other terms and conditions remain unchanged.
