

**SUPPLEMENT AGREEMENT NO. 2 – Amendment 2  
INTERGOVERNMENTAL AGREEMENT (IGA)  
FOR SHARING OF TELECOMMUNICATIONS FACILITIES AND NETWORK INFRASTRUCTURE  
BETWEEN  
THE CITY OF PHOENIX, IGA No. 100502 - SA 2 - 002  
AND  
THE CITY OF TEMPE, IGA No. C99-238A**

Pursuant to Intergovernmental Telecommunications Facilities Sharing Agreement No. 100501 and C99-238A, respectively, ("Sharing Agreement") entered into as of the 1<sup>st</sup> day of June, 2002, (the "Effective Date"), the City of Phoenix (PHOENIX) and the City of Tempe (TEMPE) now desire to enter into this Amendment 2 to the site-specific agreement Supplement No. 2 ("Supplement") to the Sharing Agreement.

PHOENIX and TEMPE, by way of this Amendment No. 2, hereby amend Supplement Agreement No. 2, by revising Section 6 of Amendment No. 1, Term to read as follows:

6. **TERM:** The term of this SUPPLEMENT shall be coterminous with the underlying SHARING AGREEMENT.


